She gave a shoutout to Reese and Emilia for organizing a great Thanksgiving Feast and reminded senators to complete the required monthly report.

7. Discussion Items

1. *Krista Stellmacher Presentation*

Hosted the Spirit of Mesa event and thanked all speakers and volunteers who contributed. Reported that the event raised a net income of \$180,000 and expressed appreciation to the students for attending and helping shape the event. Announced the start of another fundraising campaign through high-income philanthropic companies. Highlighted the importance of having photos available when high-net-worth individuals visit Mesa. Mentioned that MacKenzie Scott, Jeff Bezos's ex-wife, is currently funding nonprofit organizations and community colleges. Asked students to share what they would like to see at Mesa to improve their education and campus experience. Distributed a flyer with a survey for students to provide input on campus needs. The survey will remain open indefinitely, with the first review period closing on December 11th.

2. *Grows & Glows – Thanksgiving Feast*

Reese: Suggested keeping Bingo for next year.

President Palomino: Shared that he liked the gifts and prizes, noting that they complemented the overall theme of the event.

Tonya: Pointed out that the Bingo prizes and raffle prizes were different and should be clearly separated, as many people took the gift cards.

Reese: Recommended allowing an additional day for setup. Noted that the arts and crafts section should be more separated, as it became chaotic. Emphasized the need for more volunteers and expressed gratitude for those who did help. Mentioned, there was a lack of communication between her and Emilia, which created stress for the volunteers.

Ramiah: Suggested moving the prize table to the front of the room and increasing publicity for events. Encouraged ASG to be more present on campus and communicate with students directly to share information.

President Palomino: Encouraged ASG members to be visible on campus, engage with students, and share positive messages about ASG.
